# Quick guide to finding information on the new chemicals legislation

European chemicals legislation has changed over recent years with the introduction of the REACH (Registration, Evaluation, Authorisation and restriction of Chemicals) and Classification, Labelling and Packaging (CLP) Regulations. Their purpose is to protect human health and the environment whilst preserving the competitiveness of industry and ensuring the free movement of chemical substances within the EU. The European Chemicals Agency (ECHA) ensures the consistent implementation of these regulations across the European Union.

ECHA's website is a single point of entry point for information on REACH and CLP.

#### **WEB LINKS**

The following information is available in 22 EU languages on our website:

**ECHA news** (http://echa.europa.eu/news\_en.asp) informs about the most important technical and regulatory developments. Translations are provided online two weeks after the news is published in English.

**CLP** (http://echa.europa.eu/clp\_en.asp) dedicated web pages with detailed guidance on the classification, labelling and packaging of substances and mixtures (CLP) regulation.

**REACH** (http://echa.europa.eu/reach\_en.asp ) gets you started with REACH requirements, the chemicals covered and the tools to help you.

**SIEF** (http://echa.europa.eu/sief\_en.asp) gives an overview of the critical information on Substance Information Exchange Fora (SIEFs) and how to prepare for registration under REACH.

**Data sharing** (http://echa.europa.eu/datasharing\_en.asp) is one of the core principles of REACH. Companies should jointly submit dossiers and share information on substances. This increases the efficiency of the registration system, reduces costs and discourages unnecessary testing on vertebrate animals.

**Guidance** (http://guidance.echa.europa.eu/) helps you to understand your obligations under REACH and how to fulfil them.

**REACH-IT** (http://echa.europa.eu/reachit\_en.asp) companies submit data and dossiers on chemical substances with this tool.

**Navigator** (http://echa.europa.eu/navigator) helps you to understand your obligations under REACH and to find appropriate guidance on how to fulfil them. Twenty language versions of the Navigator are available on ECHA's website. The Polish authorities host the Polish version, the French version will be available before the end of 2012 and a Croatian version is coming in 2013.

**C&L notification** (http://echa.europa.eu/clp/inventory\_notification/notification\_how\_en.asp) is a spreadsheet application that allows you to generate your Classification and Labelling (C&L) notification.

**C&L inventory** (http://echa.europa.eu/web/guest/information-on-chemicals/cl-inventory) is a database containing the C&L information of substances notified to ECHA. It also includes the list of legally binding EU harmonised classifications according to the CLP criteria.

**SME pages** (http://echa.europa.eu/support/small-and-medium-sized-enterprises-smes) provide information and support specifically targeted to small and medium-sized enterprises.

Webinar presentations	Webinars are information sessions that ECHA hosts online. They consist of presentations and question and answer sessions. The Agency provides an online multilingual terminology database with more than 900 key REACH and CLP terms and their definitions in 22 EU languages, ECHA Term. Users can download terms in one or more languages, for example CLP hazard and precautionary statements.
